We act as Solicitors for Mr Mohamed Bangura who is the complainant with reference to the above mentioned subject who was relieved of his position by His Excellency the PRESIDENT DR. ERNEST BAI KOROMA of the Republic of Sierra Leone and whose behalf and under whose instructions we now write you this letter.

Our instruction states:

1. The Reinstatement of our Client as Director General of NATCOM with immediate effect.
2. Full payment of all outstanding salaries and benefits from 1st April, 2015 to the effective date of his reinstatement.
3. Full Compensation for Reputational damage, Embarrassment, Inconvenience, Trauma and the adverse effect it had on his family.
4. Our client further instructs us that he is open to any alternative dispute resolution to resolve this alarming situation with the appropriate authorities of the Commission.
5. That we are advising you to meet your contractual obligations with great urgency to avoid any embarrassment and litigation as several attempts have been made to alleviate this dire situation.
6. Failure to respond will leave us with no alternative option but to take drastic legal action against NATCOM within 14 days on the receipt of this letter in a competent jurisdiction.
